INSTRUCTION TO BIDDERS

1. TENDERS

Tenders, clearly marked, "GRAVEL ROAD DUST SUPPRESSANT - RMW #2024-03" will be accepted by the RM office up to 4:00 pm local time, Friday, February 16, 2024 for the supply, haul and application or supply only of gravel road dust suppressant as per the attached specifications.

2. COMPLETION OF BID DOCUMENTS

All Bids shall be submitted on the forms included in these Tender Documents as listed on the Tender Submission and each such document shall be completed in accordance with these Instructions to Bidders.

3. ENCLOSURE OF COMPLETE DOCUMENTS

- a) All Tender Documents, including those requiring completion, shall be filled in and returned intact.
- b) The tender submission shall consist of the following:
 - FORM A Schedule of Prices (signed and completed)
 - FORM B Schedule of Equipment (signed and completed)
 - FORM C Schedule of Sub contractors (signed and completed)
 - FORM D Gravel Road Dust Suppressant Sheet

4. INFORMATION

Tender forms, specifications and other information may be obtained at the office of the Rural Municipality of Riding Mountain West, Inglis Manitoba.

5. CLARIFICATION

The RM reserves the right to seek clarification with the Bidder to assist in making evaluations.

6. WITHDRAWN

The RM reserves the right to withdraw any or all tenders or any portion thereof.

7. PRICES

All prices shall be freight on board, Rural Municipality of Riding Mountain West, Manitoba. The RM is not subject to the Federal Goods and Services Tax (Registration Number 130245178RT0001). Provincial Sales Tax, where applicable, shall be stated separately.

8. PAYMENT

Unless Bidder specifies otherwise, payment will be made within 45 days of receipt of invoice.

SECTIONS 9 – 11 ARE APPLICABLE TO THOSE BIDDING ON SUPPLY, HAUL AND APPLICATION

9. QUALIFICATIONS

- a) The bidder shall provide a minimum of \$2,000,000 third party liability covering the RM of Riding Mountain West during the term of this contract.
- b) The bidder shall provide a current confirmation of good standing with the Worker's Compensation Board.
- c) The bidder shall be responsible for all permits associated with this tender.
- d) Each bidder shall be prepared to submit, on request of the RM, the following information:
 - i. Proof that they are incorporated or other authorized to do business in Manitoba.
 - ii. Proof that they are financially capable of carrying out the terms of the contract.
 - iii. Proof that they have successfully carried out work, similar in scope and value, or is fully capable of performing the work required to be done in accordance with the terms of the contract.
 - iv. Such other pertinent data as may be required by the RM.

10. SUBCONTRACTING

Bidders who propose to sublet any portion of the work shall give a complete list of the Subcontractors who they propose to engage with and a description of the work to be sublet. Where the Subcontractors are not identified on FORM C, it will be interpreted that the Bidder proposes to execute that class of the work with the Bidder's own forces.

11. LICENSING

The services shall be performed in accordance with the existing Federal and Provincial regulations. The Contractor shall obtain all applicable licenses required for the completion of this work. The Contractor shall be responsible for any or all charges imposed by such regulations.

12. ENFORCEMENT OF REGULATION

The Contractor shall abide by all fire, safety, Environmental Laws in the Provincial of Manitoba.

13. INVOICING

- a) Invoicing shall be done at completion of the job, showing amount of product supplied and/or amount of product supplied and location of applications and referencing any applicable RM work order number.
